## **RULES AND REGULATIONS OF POSTGRADUATE (MD/MS) ADMISSION IN JNIMS, IMPHAL-2025-2026**

### **1. Duration of courses:**

<b>MD/MS</b>	The course will be of 3 (three) years from the date of admission and 2 (two) years those with recognized two years P.G. Diploma holders in the same subject

### **2. Eligibility Criteria:**

Candidate must be an Indian national holding MBBS degree or equivalent from a Medical College / Institute recognized approved by National Medical Commission (NMC) of India and has obtained permanent registration from NMC and NEET-PG 2025 qualified. The allotment of seats will be strictly done in order of merit of the National Eligibility cum Entrance Test (NEET-PG-2025).

### **3. Categories of Postgraduate Seats:** There are three categories of Post-Graduate seats available in Jawaharlal Nehru Institute of Medical Sciences, Imphal as per “ The Manipur Medical Postgraduate Seat Allotment Schemes, 2025” published in Manipur Gazette dated 14<sup>th</sup> November, 2025:

- (A) In-Service Category
- (B) Direct Category
- (C) Institutional Preference Category

### **4. In-Service Category:**

- (i) Candidates working in Manipur Health Services under the Health & FW Department, Government of Manipur or JNIMS on regular basis only will be considered.
- (ii) Candidates who are appointed on temporary/contract basis or ad-hoc appointment are not considered under the ‘In-Service Category’.
- (iii) For candidates who have served in remote and difficult areas as defined by the State Government in its order No.4/2/2012-M(PG) dated 08/02/2013, as amended from time to time, **a difficult area posting certificate issued by the Directorate of Health Services, Govt. of Manipur shall only be considered valid.**
- (iv) Admission for the In-Service candidates will be cancelled at any time if they have been admitted in the postgraduate course by submitting false information or documents.
- (v) Any other matter related to admission and not addressed herein will be sent up to State Level Medical PG Selection Committee for the final decision

### **5. Direct Category:**

- (i) Direct Category: Candidate must be an Indian national holding MBBS degree from any recognized Medical College / Institute/ University recognized by MCI/NMC, and has obtained permanent registration from NMC or State Medical Council.

### **6. Institutional Preference Category (JNIMS Product):** Candidate must be an Indian national holding MBBS degree from Jawaharlal Nehru Institute of Medical Sciences (JNIMS) Imphal and must have obtained permanent registration from NMC or any state Medical Council.

## 7. Submission of Application Form:

- (i) A candidate seeking counselling for admission is required to submit his/her application in the **prescribed form only**.
- (ii) The candidate should fill in the application form in his/her own handwriting, clearly and legibly.
- (iii) Application form should reach the Office of the Dean (Academic), A-Block, Jawaharlal Nehru Institute of Medical Sciences, Porompat, Imphal – East, Manipur – 795005 from 24/11/2025 to 12:00 Noon of 29/11/2025 . Application(s) received thereafter shall not be entertained under any circumstances. JNIMS, Imphal will not be responsible for any delay. ***Further, request for extension of last date for submission of filled in application form through proper channel for the In-Service candidates shall not be entertained.*** For those applicants who cannot submit the form physically, they may submit the same in PDF format at [academic.jnims24@gmail.com](mailto:academic.jnims24@gmail.com)
- (iv) The candidates are required to pay a requisite counselling fee of Rs 1300/- (Rupees One Thousand Three Hundred) only through online transaction given below:

- (v) The Counselling Fee is Non-Refundable.
- (vi) Incomplete application forms shall be rejected and no correspondence will be made by the Institute in this regard,
- (vii) Application form for all In-Service and In-Service applying for Direct Categories candidates should be countersigned by State Health service/competent authority.

## 8. Allotment of Seats:

It will be strictly based on the marks obtained in the NEET – PG-2025 Examination and selection will be purely on merit basis, according to the ““The Manipur Medical Postgraduate Seat Allotment Schemes, 2025” published in Manipur Gazette dated 14<sup>th</sup> November, 2025.

***Candidates who are not eligible / qualified in their respective categories shall not be considered for selection.***

## 9. Inter-se-merit of candidates obtaining equal marks:

In case of two or more candidates obtaining equal marks in the NEET-PG-2025 the inter-se-merit of such candidates shall be determined by all India NEET-PG 2025 Rank.

## 10. Counselling:

Counselling will be conducted in **Hybrid mode**. Choice of subject as allotted on the basis of personal counselling will be final. Schedule for State Level Medical PG Counselling 2025 is fixed as below as notified by Director of Medical Education, Government of Manipur vide notice no.DME-5/1/2025-HEALTH dated 21<sup>st</sup> November 2025 :

**\*All candidates should check the JNIMS website regularly for matter related to Counselling and Admission.**

### Documents to be examined during counselling:

**At the time of counselling, the candidate is required to produce the following documents:**

- i. Acknowledgement slip issued by JNIMS, Imphal on submission of the prescribed form for PG seat in JNIMS, Imphal
- ii. Admit Card of NEET – PG- 2025
- iii. Score Card in NEET – PG- 2025
- iv. University MBBS Degree Certificate.
- v. Mark sheets of MBBS Examination (1<sup>st</sup> , 2<sup>nd</sup> , 3<sup>rd</sup> & Final)
- vi. Attempt Certificate
- vii. Internship Completion Certificate.
- viii. Permanent NMC / State Medical Council Registration Certificate.

## 11. Admission :

List of the selected candidates will be published soon after counselling. The candidates are required to get themselves admitted on or before the notified date by paying the necessary fees and submitting the following documents in original to the Office of the Dean (Academics), Jawaharlal Nehru Institute of Medical Sciences (JNIMS), Imphal, Manipur:

- a) Permanent NMC/State Medical Council Registration Certificate
- b) Mark Sheets of MBBS Examination (1<sup>st</sup> , 2<sup>nd</sup> , 3<sup>rd</sup> & Final)

- c) University MBBS Degree Certificate
- d) Admit Card of NEET – PG- 2025
- e) Score Card in NEET – PG- 2025
- f) Attempt Certificate
- g) Internship Completion Certificate
- h) Permanent NMC / State Medical Council Registration Certificate
- i) Aadhar card/Pan card

N.B. The permanent medical registration certificate should be submitted within two months of admission, failing which the admission will be cancelled.

#### **12. Joining:**

Last date of joining will be **subject to NEET PG Schedule 2025 issued by Medical Counselling Committee, Government of India.**

#### **13. Contract:**

On admission, all original certificates & other necessary documents of candidates will be retained in the Dean (Academics) Office, JNIMS, Imphal. The same will not be returned to the candidate before completion of the course. For their own convenience, one set of photocopies of the documents may be retained by the candidates. A security deposit, fixed from time to time, is to be made if the student wishes to withdraw these documents for a limited period of time related to appearance of interview etc. during the course. An undertaking will also be signed for the return of the documents within the stipulated time.

#### **14. Penalty:**

Candidates who do not join the MD/MS course after getting admitted or leaves the said course within the First year of joining shall be liable to pay a sum of Rs. 3,00,000/- (Rupees Three Lakhs) only, whereas candidates who leave the course after one year of joining shall be liable to pay a sum of Rs. 7,00,000/- (Rupees Seven Lakhs) only as compensation for such midstream departure. In such cases, the original certificates will be returned only after payment of the penalty. In addition, for the candidates admitted under the Direct & Institutional Preference Categories, they are also liable to return the cumulated salary received from JNIMS, Imphal over and above the penalties mentioned above. The sum to be paid on leaving the course and return of salary for candidates admitted under the Direct & Institutional Preference Categories are both non-negotiable.

An undertaking to this effect is to be submitted in the prescribed format by the concerned candidate at the time of admission.

Postgraduate students who changed the institute or the subject in the subsequent counselling shall not be entitled for the part salary for the duration he or she worked before leaving or changing a subject in JNIMS, Imphal.

#### **15. Salary/Stipend for In-Service candidates admitted in Direct category:**

Ordinarily, salary/stipend for the In-service candidates admitted under Direct category

shall not be paid by the Institute.

**16. Anti-Ragging Policy:**

Ragging is a punishable crime in JNIMS, Imphal under UGC and NMC guidelines.

**17. Accommodation:**

Accommodation will be as per the NMC Guidelines prescribed from time to time. Married accommodation facility is not available in the campus. Attempt will be made to provide hostel accommodation as far as possible based on vacancy.

**18. Jurisdiction:**

Any dispute arising out of selection of postgraduate students will be decided by the State Level Medical PG Selection Committee. *However, any legal dispute pertaining to selection of postgraduate students shall fall within the jurisdiction of High Court of Manipur, Imphal only.*
