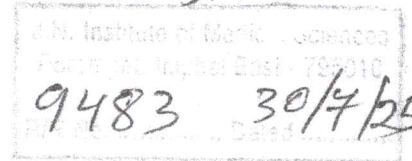

In inviting a reference to your letter No. JIMS/Academic-3(11)/Stu(Fee)/13/1004 dated 16th May, 2025 on the above subject, I am directed to convey approval of the Government to the following proposals:-

- i) To review JNIMS order dated 16/09/2022 and fix the fees for Post Graduate students of JNIMS at Rs. 1,00,000/- i.e. Rs. 50,000/- in 1st Year; Rs. 25,000/- in 2nd Year; Rs. 25,000/- in 3rd year as was before the last revision of 2022.
